

EXTENDED COOKIE POLICY DOCUMENTATION

Our Cookies Policy

This policy document is supplied by **Thermoplay S.p.A.**, controller of the data processing procedures and the website www.thermoplay.it in accordance with the privacy regulations compliant with the Provisions of the Guarantor Authority dated 8 May 2014, *“Simplified Arrangements to Provide Information and Obtain Consent Regarding Cookies”* (published by the G.U. n° 126, 3 June 2014).

WHAT ARE COOKIES AND WHAT DO THEY DO?

Cookies are pieces of information (small strings of text) created by a server and sent to the user’s browser when visiting a website.

Cookies perform a number of important functions during web use (for example, the implementation of information technology authentication, session monitoring, recording information on specific configurations for users accessing the server, improving the services performed by the website).

TYPES OF COOKIE USED BY THIS WEBSITE

Technical cookies

These cookies are required to enable the website to function correctly. They enable browsing the pages and permit searching for other functions. Without these cookies we would not be able to provide the services for which users access the website.

These cookies are not used for any further functions, and they are normally installed directly by the website’s owner or operator. They can be categorized as follows:

- Browsing or session state cookies, that permit normal browsing and use of the website; they are essential for correct site operation;
- Analytics Cookies, which can be considered as technical cookies as they are used directly by the website owner in order to gather aggregate information on the number of users and how they visit the website, in order to improve website performance;
- Functional cookies, which enable users to browse the website according to a series of criteria selections (for example, language, products chosen for purchase) in order to improve the service provided by the website.

All the technical cookies do not require user consent, but just user notification, and so they are installed automatically when the user visits the website.

PERSONAL DATA SUPPLY

The supply of user data is voluntary but necessary to enable normal browsing of the Company's website; therefore the refusal to supply the respective data would prevent normal use of the company's website.

PERSONAL DATA DISCLOSURE

In no case will the data provided be shared with third parties. However the data may be transmitted to:

1. companies providing website maintenance services;
2. public legal authorities and other public and private organizations, in order to comply with legal obligations.

Data processing will be performed by staff employed by the website owner and specifically identified as personnel authorized to process the data.

DATA PROCESSING METHODS

Data processing may be performed using information technology, hard copies, digital, electronic, magnetic and automated processes. The data collected will be stored and protected at the head office of the Company Thermoplay S.p.A., Via Carlo Viola 74. The data collected will be processed exclusively for the purposes listed above.

LEGAL BASIS FOR DATA PROCESSING

The legal basis for data processing is the pursuit of the Company's legitimate interests.

DATA RETENTION

In compliance with principles of proportionality and necessity, data will not be stored for periods longer than necessary for the implementation of the purposes listed above.

DATA SUBJECT RIGHTS

At all times, subjects to whom personal data refers have the right to receive confirmation on whether or not their personal information is being processed, and if this the case, they have the right to access this data and the respective information as detailed in article 15 of the Regulations, with the possibility of obtaining a copy of their personal data, or of correcting their data (articles 15 and 16 of the Regulations).

In addition, data subjects have the right to request the deletion of their personal data, restrictions on data processing and data portability, and they can also register complaints with the supervising authority, and object in any case, for legitimate reasons, to the processing of their data (articles 17 and following of the Regulations).
